Francisco Gonzálvez-García has been a Full Professor of English language and Linguistics at the University of Almería since 31 July, 2018 (accredited by the ANECA since 21 April, 2015). He has four live research periods granted by the CNEAI. He has supervised a doctoral thesis (S. Alarcón-Hermosilla, on a cognitive-stylistic analysis of early Works of John McGahern, 21/12/2020) and has co-supervised two doctoral theses on cognition and constructions: A. Luzondo-Oyón (on resultative constructions in the Lexical Constructional Model, U. of La Rioja, 6/9/2011) and A. Galera Masegosa (on cognitive modeling within the Lexical Constructional Model, U. of La Rioja, 12/12/2013).
