

Part B. CV SUMMARY

Luis Alfonso Camarero Rioja is Professor of the Department of Theory, Methodology and Social Change of the UNED. He combines teaching in Statistics and Social Research Techniques with research in Rural Sociology.

He began his career as a researcher at the Seminary of Rural Studies together with Professor Vicente-Mazariegos (UCM). His early works analyze the rural Spanish modernization, rural restructuring and sociodemographic change. Sample of this period are some publications: *Women and Rurality. The Broken Circle* (1991). *Socioprofessional Situation of Women in Agriculture* (1993). *From the rural exodus to the urban exodus. Decline and Renaissance of Spanish rural settlements* (1994). *Reflections on rural development: the flying system of postmodernity* (1999). *Dying in the countryside and in the city: analysis of urban-rural differences in mortality* (1999), in *Sociologia Ruralis*. *Shifting rurality: The Spanish Countryside after de-peasantisation and after de-agrarisation*. (2001, Ashgate). He has also participated in various compilation texts of current research in the field of rural studies, among which the *Atlas of Rural Spain* (2005,) or *The Irrigators: productive and socio-professional profiles* (2006).

He has coordinated several research projects about the visibility of women's work in rural areas. The findings were published: *The Unveiled Work. Occupational Trajectories of Rural Women in Spain*. (2006). *Women entrepreneurs in Rural Spain: the subject pending development* (2007).

Currently he is conducting different projects focused to social sustainability in rural areas. The main results are edited: "Why do women go? The continuum of mobility as an explanatory hypothesis of rural masculinization "; *The Rural Population in Spain. From imbalances to social sustainability*. His research findings have been debated in European forums and published in specialized collections *Foreigners, Neighbors, Immigrants: Translocal Mobilities in Rural Areas in Spain In Translocal Ruralism. Mobility and connectivity in European rural space*. Springer. *Exploring Female Over-Migration in Rural Spain- Employment, Care Giving and Mobility. Women and Migration in Rural Europe*. Palgrave-Macmillan. *The immobilities of Non-automobile Residents of Rural Spain*. Routledge

He has supervised a dozen doctoral theses. His work has been recognized with the National Prize for Agrarian Publications (MAPA) and the Doctoral Thesis Prize of the Illustrious College of Doctors in Political Sciences and Sociology. He usually collaborates with Evaluation Agencies: ANEP, ACSUCyL, ANECA. Member of Research Projects Commission, National R+D+i Plan in Social Sciences. He is a Principal Investigator of the Consolidated Social Change Research Group. As a result of his research, he has published more than 50 papers, including monographs and articles.

He has been director of the Sociology I Department (2005-2011) and Vice Dean of Research (Faculty of Political Science and Sociology, UNED). He has been visiting scholar at the City and Regional Planning School (University of Cardiff). He has held seminars at the Institute of Social Research (UNAM-Mexico) and ISCTE-IUL (Lisbon), Rural University of Rio de Janeiro and the State University of Rio Grande do Sul (Brazil) and Austral University (Chile).

He is a member of Southern and Mediterranean Europe: social change, challenges and opportunities, study group of the ESRS (European Society for Rural Sociology) and principal investigator of the Network of Excellence Socio-territorial Research and Rural Development (ISORURAL). He has been president of the Scientific Committee of the X CIER and of the Organizing Committee of the XI, XII, XIII and XIV CIER, and he is Coordinator of the Research Committee of Rural Sociology of the FES.

From 2023 he is the director of the Rural.Real (Cátedra de Población Rural y Sostenibilidad Social).
